3.0 BACKGROUND INFORMATION

3.1 On 20 September 2017 Members of the Licensing Health and Safety and General Purposes Committee approved revised Private Hire Vehicle Licence Conditions. These conditions state that:

Private Hire vehicles are not permitted to use roof racks, roof boxes, or trailers whilst being used for hire and reward purposes.

- 3.2 The proprietor of the vehicle, registration number DG59LPJ, Mrs Lewis, has requested an exemption from the above condition to allow her to fit a trailer to her vehicle when required.
- 3.3 Mrs Lewis states that she undertakes work transporting passengers to airports and other locations with luggage which does not fit in the vehicle. The types of luggage carried includes skis, golf clubs and large cases. She therefore requires a trailer to transport the luggage.
- 3.4 The vehicle and trailer will be available at the meeting for inspection...
