#### **REPORT SUMMARY**

The purpose of this report is for Members to consider an application to license a Ford Tourneo Custom A Cabbi wheelchair accessible vehicle as a Hackney Carriage Vehicle.

### **RECOMMENDATION/S**

That Members consider whether or not to license the Ford Tourneo Custom A Cabbi wheelchair accessible vehicle as a Hackney Carriage Vehicle.

1.1 It is a delegated function of this Panel to approve vehicles that can be licensed as Hackney Carriage Vehicles.

# 3.0 BACKGROUND INFORMATION

- 3.1 An application has been received from Mr S Marnell to license a Ford Tourneo Custom A Cabbi rear loading wheelchair accessible vehicle as a Hackney Carriage Vehicle. Copies of advertising literature are attached at Appendix 1.
- 3.2 The vehicle has been converted by McElmeel Mobility Services Ltd. The conversion includes fitting purpose made ramps, anchor systems and head height mouldings. Each vehicle is converted to order in Northern Ireland. Copies of a letter of conformity for the ramp and a vehicle conversion/adaptation certificate are attached at Appendix 2.
- 3.3 The vehicle has M1 European Whole Vehicle Type Approval.
- 3.4 If Members approve this vehicle to be licensed as a Hackney Carriage Vehicle Mr Marnell intends to supply converted vehicles to the Hackney Carriage Trade.
- 3.5 A vehicle will be available for inspection at the meeting and Mr Marnell will be present to answer any questions members may have.
- 3.6 If this vehicle is approved to be licensed as a Hackney Carriage Vehicle there would be an impact of the space available on Hackney Carriage ranks due to the space required for the ramp to be extended at the rear of the vehicle. This will be discussed with officers from Place Services (Traffic Network) and reported verbally at the meeting.
