# 1.0 Executive Summary

Wirral Council has received a £2.969 million funding package from the UK Governments Future High Streets Fund (FHSF) to make improvements on Grange Road, within the Charing Cross junction and on Grange Road West. The funding cannot be used for any other purpose.

The FHSF fund was set up to support and fund local areas' plans to make their high streets and town centres fit for the future. The area of Grange Road and Charing Cross is a particularly busy part of Birkenhead town centre - thanks to its variety of shops and services, the connection to The Pyramids Shopping Centre and the several car parks and bus stops nearby however was identified as needing to be improved to encourage increased footfall into the town centre and improve the attractiveness of the area.

The aim of the projects is to provide better access and connection to the services in the area and improve road safety within the town centre. The proposals include increasing safety measures for pedestrians at Grange Road, simplifying the Charing Cross junction by providing better pedestrian crossing facilities, and introducing a trial Low Traffic Neighbourhood along part of Grange Road West.

The suggested improvements are designed to provide a more attractive place for people to shop, live, visit, or work and to support the regeneration of Birkenhead town centre by providing an improved, better connected and more sustainable experience for all who use this area.

Public consultation was held on Charing Cross and Grange Road Active Travel Scheme from 28 November 2022 to 22 January 2023 allowing people to provide their view. The findings from the consultation are included in this report.

## 1.1 Key Findings

- The questionnaire was responded to by 154 people.
- Wirral council proposed three schemes:
  - Grange Road scheme (Question 1) which aims to improve the look and feel of Grange Road, and to improve accessibility. 81.0% of the responses supported the proposal whilst 19.0% objected.
  - Charing Cross scheme (Question 2) which aims to improve road safety and connectivity for pedestrians at the Charing Cross junction. 81.2% of the responses supported the proposal whilst 18.8% objected.
  - Grange Road West scheme (Question 3) which is to trial as a Low Traffic Neighbourhood along part of Grange Road West – between the Charing Cross junction and Clayton Street. 73.9% of the responses supported the proposal whilst 26.1% objected.
- The most common themes for people supporting the proposals were that they would 'Improve the area in general' and 'Improve the appearance and functionality of the area'.
- The most common themes for people objecting to the proposals were 'The area needs change but would prefer different solutions' and 'Unlikely the objectives will be achieved'.
- The most represented ward was Birkenhead and Tranmere (20.1%) followed by Oxton (18.1%) and Claughton (13.4%). No responses were received from residents of Moreton West and Saughall Massie or Liscard.

# 2.0 Methodology

Through the Charing Cross and Grange Road Active Travel Scheme Consultation, people were asked to tell us about their views on the proposed schemes covering, Grange Road, Charing Cross, and Grange Road West.

The consultation was carried out between 28 November 2022 – 22 January 2023. The approach used was an on online public consultation through the 'Have your say' consultation portal at <a href="www.haveyoursay.wirral.gov.uk">www.haveyoursay.wirral.gov.uk</a> with a page dedicated to the Charing Cross and Grange Road Active Travel Scheme Consultation. Useful information provided on the site included a map and artist impressions of what the area might look like.

An online questionnaire was provided for residents to engage with. Respondents were also able to request paper copies, request help in completing the questionnaire, or submit additional comments via a dedicated email address, which was published on the 'Have your say' website alongside the online questionnaire.

## 2.1 Questionnaire

The consultation questionnaire was developed around understanding stakeholder views on the following three key areas of the scheme:

- Grange Road. This scheme aims to improve the look and feel of Grange Road, and to improve accessibility. This includes replacement of paving materials, new trees, upgrading of the street furniture and implementation of timed vehicular access restrictions at the junction of Grange Road & Charing Cross.
- **Charing Cross.** This scheme aims to improve road safety at the Charing Cross junction. It includes replacement of the existing crossings with wide, straight crossings and replacement of pavement with quality surfacing.
- Grange Road West. The third scheme is a trial as a Low Traffic Neighbourhood along part of Grange Road West – between the Charing Cross junction and Clayton Street. This includes; coloured surfacing and planters to identify the boundary between the pedestrian area and one way traffic.

To enable further understanding, and in-depth analysis, respondents were invited to provide free-text comments to expand on their support or opposition, ideas and concerns. Following closure of the consultation, the responses to each of the direct questions were collated and the responses included in this report. For the free-text comment questions, a text coding approach was used based on the reoccurring themes. This data was then collated and summarised in the report. Their full answers are also listed in the Appendices 1, 2 and 3.

## 2.2 Analysis of Respondents

Respondents to the online tools were provided with the option to provide demographic information about themselves. It must be noted that this is an option and that not all respondents included this information. This data allows the demographic results to be included in this report to enable analysis of the scope of responses and representation from different demographic groups.

## 2.3 Interpretation of Results

In terms of the results, it is important to note that:

- The public consultation is not representative of the overall population but provides information on the opinion of those residents who engaged.
- Free-text questions that offered respondents the option to provide written feedback could have covered multiple themes. Therefore, with free-text responses were categorised using a coding system. The percentages given reflect the percentage of respondents who made the comment and as they may have made more than one comment, the total percentage may exceed 100%.

#### 2.4 Communication

The consultation for Grange Road and Charging Cross was promoted through the council's channels and local media channels to reach Wirral residents and encourage them to have their say on the proposals. This included issuing the following content throughout the consultation period:

- Page on Have Your Say (under the active travel hub)
- Organic social media (content shared across Facebook and Twitter)
- Media releases issued to local print and digital media (covered in Place North West, Liverpool Echo, Birkenhead News and Wirral Globe)
- Wirral View news articles
- Resident email Wirral View
- Plans and display boards at BirkenED's Place (a place for people to visit, look at the plans and engage with the consultation)

# 3.0 Results

## 3.1 The Questionnaire

The online survey was responded to by 154 people and no paper copies were submitted to Wirral Council. No questions were mandatory so respondents could choose which questions to respond to.

#### 3.1.1 Question 1: Do you support or object to the planned proposals for Grange Road?

153 people answered this question. Respondents selected one option that they agreed with. 81.0% of the responses supported the proposal whilst 19.0% objected.




Figure 1: Chart displaying results to "Do you support or object to the planned proposals for Grange Road?"

The respondents were then asked if they supported the proposal to please tell us why. 121 people answered this free text question, and they may have discussed more than one theme. A list of their responses can be found in Appendix 1. 'Improve the area in general' (32.2%) was the most common theme with respondents stating their support and the need for regeneration. The next most popular themes were 'Improve the appearance and functionality of the area' (24.0%), 'Better for pedestrians' (19.8%) and 'Improved safety for the road users and pedestrians' (17.4%).

A group of respondents replied stating their support but also had suggestions and concerns (9.1%). These centred around wanting a cycle lane included in the design, wanting direct support to business in the area and questioning the long-term sustainability of the schemes ambitions if anti-social behaviour is not addressed.




Figure 2: Chart displaying the top 10 response themes to "If you support the planned proposals for Grange Road please tell us why"

The respondents were asked to provide their reasons for if they objected. 27 people answered this free text question and they may have discussed more than one theme. A list of their responses can be found in Appendix 1. 'Unlikely the objectives will be achieved' (44.4%%) was the most common theme with respondents advocating that regeneration would require larger investment that planned in this proposal and that regeneration would not be achieved without addressing anti-social behaviour and low income. These sentiments were reflected by respondents who discussed 'The area needs change bout would prefer different solutions (33.3%) and 'Money could be spent on better things' (18.5%).

Respondents were also concerned about the traffics measures leading to reduced access to the area (18.5%) by people who rely on vehicles (such as delivery drivers, parents with young children, the elderly and disabled). Some were also concerned that the proposal would divert traffic onto surrounding roads leading to increased traffic (7.4%) elsewhere.




Figure 3: Chart displaying all response themes to "If you object to the planned proposals for Grange Road please tell us why"

#### 3.1.2 Question 2: Do you support or object to the planned proposals for Charing Cross?

154 people answered this question. Respondents selected one option that they agreed with. 81.2% of the responses supported the proposal whilst 18.8% objected.




Figure 4: Chart displaying results to "Do you support or object to the planned proposals for Charing Cross?"

The respondents were then asked if they supported the proposal to please tell us why. 112 people answered this free text question, and they may have discussed more than one theme. A list of their responses can be found in Appendix 2. Many of the themes, suggestions, and concerns regarding the Charing Cross proposal where the same as those regarding the Grange Road proposal previously stated. However, for the Charing Cross proposal, 'Improved safety for road users and pedestrians' (33.0%) and 'Better for pedestrians' were the largest reasons for supporting it.

A similar proportion of respondents stated their support but also had suggestions and concerns (9.8%). These also centred around wanting a cycle lane included in the design and questioning the long-term sustainability of the schemes ambitions if anti-social behaviour is not addressed. In addition, some respondents stated they would like features which would better manage traffic flow through the area.




Figure 5: Chart displaying the top 10 response themes to "If you support the planned proposals for Charing Cross please tell us why"

The respondents were also asked to provide their reasons for if they objected. 24 people answered this free text question, and they may have discussed more than one theme. A list of their responses can be found in Appendix 2. Again, many of the reason for objecting to the Charing Cross proposal were the same as those regarding the Grange Road proposal. However, the largest reason for objecting was 'The area needs change but would prefer a

different solution' (50.0%). Many of these respondents stated the proposal does not sufficiently address the need to better manage traffic in the area.




Figure 6: Chart displaying all response themes to "If you object to the planned proposals for Charing Cross please tell us why"

# 3.1.3 Question 3: Do you support or object to the planned proposals for Grange Road West?

153 people answered this question. Respondents selected one option that they agreed with. 73.9% of the responses supported the proposal whilst 26.1% objected.




Figure 7: Chart displaying results to "Do you support or object to the planned proposals for Grange Road West?"

The respondents were then asked if they supported the proposal to please tell us why. 103 people answered this free text question, and they may have discussed more than one theme. A list of their responses can be found in Appendix 3. Many of the reasons given for supporting the proposal were again, the same as the previous questions.

'Improve the area in general' (27.2%) was the most common theme with respondents with the next most popular themes were 'Attract and support business' (17.5%), 'Better for pedestrians' (17.5%) and 'Improve the appearance and functionality of the area' (17.5%). For those who would prefer changes (14.6%), the suggestions and concerns state were the same as the previous questions.

The respondents were asked to provide their reasons for if they objected. 32 people answered this free text question, and they may have discussed more than one theme. A list of their responses can be found in Appendix 3. Again, many of the reasons for objecting to the proposal were the same as the previous questions, however a larger proportion of respondents to this question cited reducing vehicle access (25.0%) and increasing traffic in the surrounding area (25.0%) as their reasons for objecting.




Figure 9: Chart displaying all response themes to "If you object to the planned proposals for Grange Road West please tell us why"

# 4.0 Demographics and Site Traffic

## 4.1 Demographics

Registration was required to engage in the online Charing Cross and Grange Road Active Travel Scheme consultation. The registration form included questions regarding demographics including gender, age group, ethnicity, and sexual orientation, however not all questions in the registration form were compulsory and respondents could choose to select 'prefer not to say' or skip the question. The demographics results are summarised below.

Most respondents (84.9%) of the respondents classed themselves as local residents.

54.7% of respondents identified as female and, 44.0% male. 0.7% preferring not to say and 0.7% preferring to use their own term.




Figure 11: Chart displaying gender of respondents

The age group profile is illustrated below with the most common age groups being 34-55 years (25.0%), followed by 55-64 years (22.3%) and 45-54 years (20.3%). 16-24 years only made up 3.4% of respondents.




Figure 12: Chart displaying age group of respondents

83.8% of respondents were heterosexual, 2.7% were gay/ lesbian, 1.4% bisexual and 12.2% preferred not to say.




Figure 13: Chart displaying sexual orientation of respondents

79.7% said they did not have a disability whilst 14.5% of respondents said that they had a disability. 5.8% preferred not to say.




Figure 14: Chart displaying disability status of respondents

The majority (90.0%) of respondents identified as White – British.




Figure 15: Chart displaying ethnicity of respondents




Figure 16: Chart displaying Wirral Ward representation

## 4.2 Have Your Say - Site Traffic

Reviewing the site activity, visits, and how people visit the site can be useful to evaluate if people are aware of the site, as well as to ensure engagement activities are deployed effectively, and to a wide range of different people – enhancing public engagement in the

future. Charing Cross and Grange Road Active Travel Scheme consultation of the Have Your Say site was visited 1,927 times. Of these, 537 visited multiple project pages and 372 viewed a photo or document. 154 people in total completed the questionnaire.

These figures cannot be viewed as definitive as they are based on site tracking through 'cookies' and there are a number of factors that can impact on this. These include that cookies may be disabled or deleted, individuals may access the site multiple times through different devices or different browsers. However, the figures can be used to gauge how much interest has been generated in individual projects through the rate of engaged participants.

The route that people access the site is known as the traffic source. The 'Have your say' portal allows analysis to be carried out on traffic source, and if they lead to engagement in the site tools such as the questionnaire. This analysis allows a greater understanding of which communication and promotional tools to use to optimise engagement.

For this project a range of traffic sources have been reviewed and summarised in the table below. Most visits to the site were either links clicked from social media sites (1,132) or direct visits where people typed the internet address into their web browser (421). It should be noted that Direct visits generated the highest rate of engagement of 12.4% (excluding sources with low traffic volumes), meaning 12.4% of these visits resulted in completion of the survey, whereas Social Media visits had an engagement rate of 5.0%.

# 5.4 Appendix 4: Response from Merseyside Police- Walking, Public Realm & Safety Improvement Proposals

#### **Traffic Management**

With regards to the proposals, I think it is important to say that from a TM point of view there are no objections to enhancing the layout and appearance which the area will benefit. Our comments based on past experience of the issues in the area, complaints received by both the Local Authority, BID and Merseyside Police are as follows: -

# <u>Grange Road West (between Charing Cross and Clayton Street) Low Traffic Neighbourhood</u> (LTN)

- 1. A chicane style layout has been suggested with 'pop-up planters'. Concerns are that a TRO and signage along will not prevent this illegal access. Further detail would be helpful to show how roads users, especially delivery riders, will be discouraged from travelling east through the LTN to Charing Cross.
- 2. Loading Bays have been suggested. Can further detail be provided regarding time restrictions and how they will be enforced?
- 3. Will there be time restrictions for west bound access to the LTN from Charing Cross?
- 4. I understand that the LTN will be implemented as an experimental Temporary Traffic Regulation Order which would normally be reviewed after 6 months and can be extended for up to 18 months. Until a review is completed and a permanent TRO is in place Merseyside Police would not normally carry out enforcement at the location.

#### **Charing Cross junction improvements**

1. Advanced Stop Line (ASL) noted on remaining 3 x approaches including a single stage crossing at the junction with Exmouth Street – no objections

#### Grange Road

- 1. A review of the current TRO is being undertaken. When finalised please provide further detail of the revised TRO to prohibit access.
- 2. Ongoing problems outside McDonalds, Charing Cross. What proposals are there to deter the congregating of delivery riders on both pedal cycles and motorised scooters outside McDonalds? It can lead to ASB and endangers pedestrians.
- 3. Further detail regarding bollard control access at Charing Cross; Catherine Street & St John Street required. 24 hours emergency service access will be required.
- 4. The installation of fixed bollards to prohibit vehicular access at Vincent Street & Horatio Street noted and welcomed.

5. Street furniture is generally in a poor state of repair and some signage is misaligned or missing. A refresh of the signage on all access points is needed to reinforce the revised TRO.

#### **Designing Out Crime**

To mirror the above, there are no objections to enhancing the layout and appearance of the area however I would like to offer some brief comments based on the available information at this time which relates to the initial proposal and past experiences while working as the force Design out Crime Officer (DOCO) for Wirral.

#### **Access and Movement**

- The proposal has been designed with public space and movement through public space in mind, for pedestrians and cyclists. This will be appreciated by users of the space but will potentially result in the location becoming a crime generator; a result of existing crime promoters in the locality and the attraction that a new space or development can bring.
- 2. The creation of the new public realm could make the space difficult to police, particularly in relation to anti-social behaviour (ASB) where large groups of youths/street drinkers will have the opportunity to select various escape routes. To counter this, good surveillance opportunities should look to be incorporated through the use of lighting and CCTV which will help to deter offenders and identify and target those responsible for crime and ASB.
- 3. The existing problems with delivery riders/cyclists congregating and causing issues outside of McDonalds will no doubt transfer onto the proposal. There is on-going partnership work with McDonalds to encourage change and formulate an alternative approach. This may lead to enforcement in order to alleviate the "chaos" and public risk that has previously witnessed several violent crimes.

#### **Structure**

1. As referenced within the Traffic Management comments, much of the street furniture is in a poor state of repair. The use of new planting to identify routes, create an aesthetically pleasing space and control the movement of pedestrians/cyclists will help to regenerate the area however I recommend that street furniture, in particular benches that are in proximity to shop frontages are reconsidered and removed. Benches and seating area encourage offenders to linger within the area which promotes crime and ASB. In recent times benches have encouraged rough sleeping and street drinking, particularly outside Asda on Grange Road (which was previously an ASB hotspot) where benches were removed some 18-24 months ago.

#### <u>Surveillance</u>

1. To support natural surveillance opportunities a thorough lighting strategy through the use of light emitting diode units (LED) is recommended which will ensure a full, even

- coverage of light throughout the hours of darkness. This will help to alleviate a fear of crime, particularly in relation to lone females/violence against women and girls (VAWG) and gang culture in relation to ASB.
- 2. Where possible, new CCTV units should look to be incorporated sporadically along Grange Road, Charing Cross and Grange Road West. This will help to reduce the fear of crime that local businesses have already disclosed and will help to identify and prosecute offenders of crime.

#### Activity

- 1. The regeneration of Grange Road, Charing Road and Grange Road West will look to increase use and activity throughout the space however the concerns of existing business owners were made apparent during the walkthrough on Friday 20<sup>th</sup> January 2023, particularly in relation to street drinking, begging and shoplifting. Advice was given to provide formal responses via the planning portal and whether or not this is done by the community; the encounter provided a clear indication of the struggles that existing business owners have. This is something to bear in mind given the proposal will look to attract new business into the area.
- 2. There are some crime generators which are out of the proposals control which include the YMCA on Whetstone Lane and McDonalds on Grange Road; both of which have been crime generators for street drinking and anti-social behaviour over recent years. It is likely that both of these sites will continue to cause issues in proximity to the proposal just because of their very nature and use.

#### Management and Maintenance

1. It is important that the public realm along Grange Road, Charing Cross and Grange Road West be regularly serviced; with bins emptied, green space maintained and any damage being either repaired or replaced to discourage the early stages of the 'broken windows theory'.
