Section 2: What Council proposal is being assessed?

Reduction in LAC numbers

The overall children looked after numbers in Wirral appear to be high compared to statistical neighbours and is due to inadequate practice pre 2019 as per our 2016 inspection, our subsequent Ofsted visits identify improving practice . The numbers coming into care presently are more in line with neighbours. The cohort of children who joined during this period are likely to remain in care until age 18. If this had not been the case we would expect our CLA figures (and our expenditure) to be aligned with that of our statistical neighbours at 101 per 10,000 population. As these pre 2019 children reach 18, and leave the care system, we anticipate our CLA spending will reduce annually (assuming our incoming CLA remain at current levels). The impact of this has been modelled to produce savings.

Over time, as the impact of inadequate practice works its way out of the system we will once again align with our Statistical Nearest Neighbour average spend.

We have a strong Early Help Alliance and prevention framework in place to ensure children, young people and families get help at the earliest possible stage to prevent them entering the care system if avoidable. This includes initiatives like Cradle to Career, PAUSE and our Family Help Offer.
