Monitoring

- 3. Number of measures installed under ECO4 and the Great British Insulation Scheme:
- 4. Proportion of homes rated Energy Performance Certificate A-C and D-G;
- 5. Number of homes benefiting from local schemes (e.g. Home Upgrade Grant, Solar Together).

Glossary

ECO4 - Energy Company Obligation 4 (ECO4) is a government energy efficiency scheme in Great Britain designed to tackle fuel poverty and help reduce carbon emissions. ECO4 applies to measures installed from 1 April 2022 and will cover a four-year period until 31 March 2026. The ECO scheme works by placing a Home Heating Cost Reduction Obligation (HHCRO) on medium and large energy suppliers. Under HHCRO, obligated suppliers must promote measures that improve the ability of low-income, fuel-poor and vulnerable households to heat their homes. This includes actions that result in reduced energy usage, such as installing insulation or upgrading a heating system. The intention of the scheme is to offer a "whole house approach" to retrofit to lift a property up one or more Energy Performance Certificate bands.

Fuel poverty – a household is considered to be living in fuel poverty if:

- it is living in a property with an energy efficiency rating of band D, E, F or G as determined by the most up-to-date Fuel Poverty Energy Efficiency Rating Methodology; and
- its disposable income (income after housing costs and energy costs) would be below the poverty line.

Great British Insulation Scheme – this is a new energy supplier obligation to run in tandem with ECO4, the aim of which is to deliver energy efficiency upgrades in homes in Great Britain. It differs from ECO4 in that eligibility is based on living in a home in the lower council tax bands, with an EPC of D and below and offers the installation of a single retrofit insulation measure with the cost partially or fully subsidised by the energy company. The legislation to allow the scheme operate received parliamentary approval on 3rd July 2023 and commenced later in 2023.

Local Advice Demonstrator Programme - The North West Net Zero Hub is working with the Department for Energy Security and Net Zero and the four other Net Zero Hubs to deliver a Local Energy Advice Demonstrator programme that will fund innovative projects piloting new approaches to providing local in-person energy advice. The programme will provide funding of up to £2m to individual projects that

can be delivered over the 2023-2024 and 2024-2025 financial years. The aim of the local energy advice pilots is to test various approaches to delivering in-person advice, with a particular focus on harder-to-treat properties and digitally excluded consumer groups.

Net Zero - this means no longer adding to the total amount of greenhouse gases in the atmosphere. In terms of home's greenhouse gas emissions, this is commonly achieved through insulation and any remaining emissions being offset through renewable energy generation.

Solar Together – a group-buying scheme for solar photovoltaic panels and battery storage systems. Its aim is to reduce the cost of installation and provide consumer confidence in selected installers. Residents living in a participating council area and who own their own house (or have permission from the landlord to install a solar PV system) can register. It is operated by a company called iChoosr. The Liverpool City Region Combined Authority partnered with iChoosr to run Solar Together locally between August 2022 and June 2023, with another commencing in August 2023.
