Statutory consultation took place between 15 December 2023 and 9 February 2024 to bring the application for designation to the attention of those who live, work or carry on business in the area to be affected.

The application documents were placed for public inspection on the Council's website and at West Kirby Library.

A summary of the other arrangements are set out in section 8.0 of the accompanying Delegated Report.

No comments were submitted that would indicate that the designation of the proposed Neighbourhood Forum and proposed Neighbourhood Area should not take place, as applied for.
