

Accessibility group workshop - Placed notes

Accessibility workshop 30/11/23 - Notes

Attendance included local residents and activists/campaigners alongside representatives of organisations. Participants included cyclists, disabilities charities and women's safety advocates.

Options for Supported Living, Wirral Mencap, RNIB northwest, Wirral Older people's parliament, Active Wirral, Wirral Cycling Group, Merseyside Cycling Campaign, Wave Radio, and local residents.

Broadly we introduced the topic/definition and some background on why we're looking at Active Travel.

Then focused on the plans in more detail providing formats to suit a range of needs – large format, video, tactile example, written descriptions, example images of walking and cycling infrastructure and existing example streets.

Comments quite varied but generally with a focus on how you make spaces more accessible. Recognition that more detailed conversations and perhaps visits will be necessary for the detailed design.

Further detailed recorded separately but some reflections on themes included:

- Shared space acknowledged as a clear compromise and therefore needs careful design to
 make it as accessible as possible. Not all organisations will formally support shared space
 (e.g., RNIB). Ideas like signage, visual separation, surface colour, physical marker in floor to
 demarcate space, tactile paving.
- Continuous footways need thought too. Thinking about how tactiles will ensure safety for blind and partially sighted. Also thinking about cane users and loss of kerb.
- Anti-social behaviour of some on bikes how to tackle that behaviour through education, campaigns, signage. Cyclists in the group mentioned anti-social behaviour as being an issue in the parts of the route that are in Liscard Town Centre. Liscard way was flagged as being an area where young people misbehave on bikes and cause risks to pedestrians.
- Street clutter. Need to think about reducing clutter and moving lampposts etc. where
 necessary. Not juts because of the creation of obstacles but also things like creation of
 narrow gaps which guide dogs are trained not to take handlers through. Also exacerbated by
 bin days and pavement parking.
- Women's safety. If walking is to be encouraged, infrastructure needs to support safety of lone women walking. Good lighting, re-populating town centre, quiet streets, streets around transport infrastructure like stations.
- E-bikes. These are welcomed and enable more people to cycle, but some concern that the
 speeds of e-bikes (and some on other cycles) would be inappropriate for shared space in
 particular. Related to anti-social behaviour and making shared space safe. Questions about
 how you make clear the speed and behavioural expectations in shared space.
- Cyclists in the group were fond of segregated cycle lanes and cycle lanes that have a coloured surface. Generally, any provisions to demarcate cycle lanes were welcomed. On a similar point, cyclists in the group thought that the existing shared space on Tower Road approaching the bridge should not be maintained and should be demarcated as this road becomes narrow and is often congested with traffic.

Cyclists in the group recommended taking Liscard Way off the route as it is often congested
with pedestrians and wheelchair users. They felt that a cycle lane here would make accidents
more likely.

Youth Voice at Pilgrim Street Arts Centre Monday 4 December 17:00 – 18:30

3 young people and 3 youth workers (young adults)

Journey analysis and general conversation about active travel and streets.

Journey analysis (young people)

- Walking environment includes difficult crossings, e.g. because of blind corners forcing you into the street to see around the corner
- Boring bus journey, busy bus
- There is a lollypop crossing person helping at a difficult junction near school
- There was a nice tree cut down which is sad
- Too many leaves left on the pavement makes walking dirty and dangerous
- Journey to beach requires going through dodgy areas and dodgy streets/alleys
- Busy road separates residential area from beach which is a shame and disconnects things. 'Zoom DIE' – perception the road is too fast and dangerous.
- Beach has pollution and litter which is sad when you arrive at what should be a peaceful natural place
- Journeys typically involved some vehicle or public transport

Journey analysis (youth workers)

- One based on long car journey not relevant to our discussion unfortunately
- Walks through green areas to make journey more pleasant
- But social / ASB issues within the park
- Connects with train station
- Walk through the historic Georgian area in Birkenhead which is nice to enjoy the buildings
- Walk includes nice houses with fun Christmas decorations
- Also passes some rundown abandoned houses which aren't nice to pass / look at
- Pass some nice buildings or community assets church and community centre which feels nice to see

Conversation (Issues and problems)

- Public transport ticketing issues make public transport journeys more difficult therefore less likely to walk as part of that journey because you'd drive. Ticket out to Edge Hill for students doesn't work
- Pollution in some areas makes them unpleasant to walk in
- Bus frequencies make bus journeys less attractive
- Need support for older people or disabled people to use public transport
- Rural roads are too difficult to imagine safe cycling to connect with these sorts of the urban cycle lanes
- Swirly junction on Tower Road is bad. Don't understand what it is.
- Tower Road walking space is good
- Could do with more greenery in general to improve walking environment
- Some pedestrian crossings don't work

- Cycle lane kerbs make crossing the road at any chosen point more difficult. Could be a
 problem for disabled people or for young people who want to avoid another group or
 intimidating individuals. The kerbs force you to cross at fewer points. We should enable
 people to cross where they feel comfortable and need to.
- Cycle lanes which don't connect or don't go anywhere

To make things better...

- Good wheelchair access
 - Smooth pavements, fixed pavement problems, pavement parking, space for wheelchair on the bus
- Bus shelters to make waiting for the bus more comfortable but also more possible for those who might be vulnerable or not able to wait in the wet and cold for long
- More buses the current frequencies are poor meaning that busses that do come are really busy, especially at rush hours. E.g. 487. Connected to the problem of wheelchair spaces being unavailable on the bus at busy times.
- Improve the look of the Birkenhead tunnel with art work
- Good lighting for safety
- Art on streets is good but should be local artists, providing local artists with opportunities
- More greenery on streets
- Inspirational quotes as part of artwork, e.g. Live, Laugh, Liverpool
- More benches and trees
- Less hostile architecture like benches designed to stop people lying down
- Raised roads are good slows traffic down and makes things feel more open. E.g. like parts of tower road.
 - o Easier to cross because of the raised road height and no or low kerb.
