REPORT SUMMARY

This report recommends acceptance of a tender from L&R Roadlines Ltd, company number 01803280, for essential highway maintenance carriageway works within Wirral.

The works provided under the proposed contract is to enable the Council to meet its statutory duties under Section 41 of the Highways Act 1980.

The Report supports the delivery of the Council Plan: Wirral Working Together 2023-27, specifically the themes: Safe Resilient and engaged communities, Protect our environment, people focussed regeneration and promoting independence and healthier lives.

RECOMMENDATIONS

The Director of Neighbourhood Services has agreed to:

1. endorse the competitive tendering exercise that is outlined in paragraph 3 of this report; and
2. award the contract for carriageway overbanding, screed patching and extruder lining works within Wirral to L&R Roadlines Ltd (company registration number 01803280) as the most economically advantageous tenderer for an estimated contract value of £200,000 for a term of 4 months.

SUPPORTING INFORMATION

1.0 REASON/S FOR RECOMMENDATION

- 1.1 The works provided under the proposed contract will enable the Council to carry out essential highway maintenance works to provide and lay a hot thermoplastic carriageway compliant screed to repair carriageway surfaces, provide and lay a hot, over-banding material, and extruder white and yellow road lines, with various letters and arrows on main roads. The works provided under the proposed contract is to enable the Council to meet its statutory duties under Section 41 of the Highways Act 1980.

2.0 OTHER OPTIONS CONSIDERED

- 2.1 Current contracts did not off this specialist carriageway treatment therefore this option was discounted.

3.0 BACKGROUND INFORMATION

- 3.1 In 2018 the Council brought highway service delivery back in-house using a small direct workforce supported by a number of tendered contracts. The continued delivery of the Council's highway service via an in-house plus top-up model, was approved by Environment, Climate Emergency and Transport Committee on 16 March 2021.
- 3.2 This is one of several contracts, which the Council needs to award in order to maintain the Council's highway service delivery provision. The contract has an indicative value of £200,000 based upon a hypothetical basket of works likely to be issued over the contract term of 4 months.
- 3.3 An Open Tender was placed via the Due North Chest tendering portal. One company submitted a compliant tender L&R Roadlines Ltd. This tender was evaluated on price, quality and social value submissions and moderated with the Council's Procurement Team. Details of the tender evaluation are set out in the exempt Appendix 1.
- 3.4 Quality and Social Value elements of the tender return were evaluated by 3 officers from the Highway Maintenance team, completing individual scoring sheets which were moderated as a group before being verified by Procurement and Finance. The Pricing element of the tender return was scored separately by the Quantity Surveyor on the Commercial Team, who assessed the proposed Price List rates against a "basket of works."
- 3.5 The tenderer submitted a Social Value Themes, Outcomes and Measures workbook as part of their tender submission; this outlines their proposed commitments throughout the course of the contract. The quality evaluators score the workbook with regards to the pledge content and likelihood. Throughout the term of the contract, the contractors submit a Social Value Return workbook direct to the Social Value team.
- 3.6 Both the quality and pricing final scores are brought together by Procurement in a weighted "evaluation matrix" which determines the preferred tenderer. The tender

submitted by L&R Roadlines Ltd represents the most economically advantageous tender received and Social Value Statements provided as part of the tender submission had realistic and achievable values.

- 3.7 L&R Roadlines Ltd have carried out this specialist work previously on Direct Award Contracts. Based upon previous contract awards and prices, the tendered price of the compliant tenderer shows an increase due to a 15% uplift for nightwork.
- 3.8 During previous Direct Award Contracts L&R Roadlines Ltd have performed well by delivering the works on time, on budget and have met the contractual performance requirements regarding quality.

4.0 FINANCIAL IMPLICATIONS

- 4.1 Funding for works to be delivered under this contract derives from the Council's capital budget for highway maintenance from the annual transport settlement grant through the City Region Sustainable Transport Settlement.
- 4.2 There are no additional financial implications arising from this report.

5.0 LEGAL IMPLICATIONS

- 5.1 Section 41 of the Highways Act 1980 imposes a duty on the Council, as Highway Authority, to maintain highways at the public expense. The Council also has a devolved duty to maintain and improve those parts of Liverpool's City Region's Key Route Network that are within Wirral in accordance with Section 6 of the Highways Act 1980.
- 5.2 The open procurement exercise for the commissioning of the contract for carriageway overbanding, screed patching, and extruder lining works and the appointment of L&R Roadlines Ltd to provide these works and services complies with the provisions of the Public Contracts Regulations 2015 and the Council's Contract Procedure Rules.
- 5.3 A contract for the works and services will be prepared by the Director of Law and Corporate Services to protect the Council's interests and ensure the deliverables under the contract are of satisfactory quality and standard.

6.0 RESOURCE IMPLICATIONS: STAFFING, ICT AND ASSETS

- 6.1 This proposed contract will enable the council to fulfil its statutory requirements as a highway authority. There are no additional staffing, ICT or assets implications.

7.0 RELEVANT RISKS

- 7.1 Failure to have sufficient contractor support to undertake a programme of planned highway maintenance works or reacting to defective highway conditions could result in the council not meeting its statutory duties as set out in the Highways Act 1980.

- 7.2 Failure to award the contract would lead to a deterioration of the network condition, which could have an adverse effect not only on the number of claims against the Council, but the defensibility of those claims and potential cost implications.
- 7.3 Failure to have sufficient contractor support to undertake preparation works for maintenance and improvement works on the highway could result in reputational damage to the Council and potentially the Liverpool City Region Combined Authority and may affect future funding allocations. It would also result in a failure to support the delivery of the priorities of the Liverpool City Region Combined Authority Transport Plan. Consequently, this could result in the loss or clawback of already allocated grant funding.
- 7.4 Potential risks concerning performance, quality and costs will be managed and monitored over the lifespan of the contract during monthly contractor meetings.

8.0 ENGAGEMENT/CONSULTATION

- 8.1 The decision to proceed to contract award has no specific consultation implications.

9.0 EQUALITY IMPLICATIONS

- 9.1 Wirral Council has a legal requirement to make sure its policies, and the way it carries out its work, do not discriminate against anyone. An Equality Impact Assessment is a tool to help council services identify steps they can take to ensure equality for anyone who might be affected by a particular policy, decision or activity.
- 9.2 The Highways Structural Maintenance Programme 2024/25 Equality Impact Assessment, has been checked reviewed and is still valid and can be viewed here: –

10.0 ENVIRONMENT AND CLIMATE IMPLICATIONS

- 10.1 Sustainable travel is at the heart of the Council's Climate Emergency declaration, and providing a safe and well-maintained highway is key to encouraging active travel, with cycling and walking. All relevant opportunities for innovation and efficiency to generate cost and carbon emission savings will be explored with the supplier during the term of the contract.
- 10.2 A resilient highways network is critical to the delivery of bus priority measures and high-quality walking and cycling route surfaces. As well as reducing noise and improving air quality promoting increased cycling and walking with better infrastructure will help combat climate change. By encouraging and enabling people to travel more on foot and by cycle instead of private car harmful emissions will be reduced. Promoting active travel can result in reduced emissions of Nitrogen Dioxide particulate matter and Carbon Dioxide helping to tackle climate change and improve air quality.

11.0 COMMUNITY WEALTH IMPLICATIONS

- 11.1 L&R Roadlines Ltd has provided a costed Social Value submission to deliver local community wealth benefits that will be monitored throughout the life of the contract.
- 11.2 It is considered that the SC1 Carriageway Overbanding, Screed Patching, and Extruder Lining Contract helps deliver Wirral's wider Community Wealth Building commitments to deliver a prosperous, inclusive economy that benefits residents and supports the principles of community wealth building.
- 11.3 The contract supports several key Community Wealth Building aims, including:
Local Employment – creation of local employment and training opportunities;
Maximising the Wirral Pound – buying supplies for schemes delivered through this contract locally wherever possible to support business and employment. Green and Sustainable: protecting the environment, minimising waste and energy consumption and using other resources efficiently, within the contractor's supply chain.
